- 9. Enhance the Mercer corridor from 15th Avenue West to the tunnel and I-5
- 10. Address impediment created by north portal to accessing I-5 via Mercer
- 11. Investigate a Roy Street underpass to facilitate east-west access to the tunnel and I-5
- 12. Design Alaskan Way with capacity to carry expected traffic in lieu of traveling on SR 99
- 13. Parking
- 14. Elliott Ave Intersection
