As an fyi and to make sure we are all on the same page- I placed a hard copy of the *final* SR 99 scenario A-H base cost estimate summary sheet in your inbox for your information. Bob Chandler requested and was given this same information today to share with others at the city.

This summary is dated 30-October 2008 and represents the SR 99 team's best effort at developing a conceptual level estimate for each of the SR 99 portions of scenarios A-H in support of the partnership process. This information was delivered to the AWV Program Estimator, Mike Morrison, last week to assist in his build up of the full range estimates, including risk and escalation. With this input, Mike is now working toward building up two final summary matrices of costs: one that will describe the full range estimate for SR 99 building blocks for each scenario, and one that will describe the full range estimates for all remaining building blocks for each scenario.

Our intention is to wrap up and close out this phase of the estimating process as soon as Mike completes the range estimate summaries, by November 14th. When we begin to develop hybrid scenarios, new and separate estimates will be constructed to support those new scopes of work.
