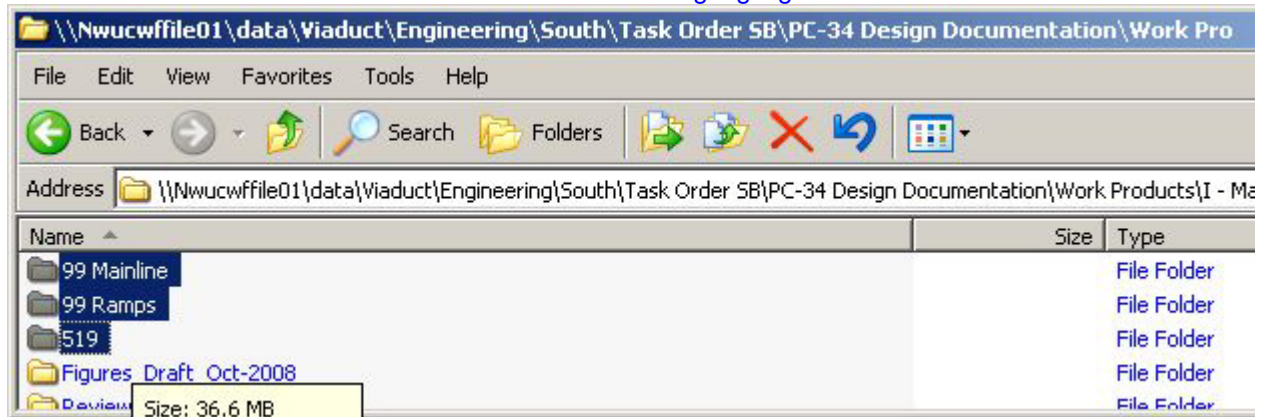
Incidentally, the final pdfs are all in the "I - Major Deviations" core directory, not distributed to the subdirectories (if I remember right).
