The code amendment I was talking about below was the overheard utility line issue. Sandy and Joyce have talked about the Staging amendment but it shouldn't impact Utility, probably only the N and S ends. Without seeing the entire language, based on what Sandy said was being changed. I would argue that the change is "necessary" so that DPD has control over staging. It basically seems to define staging as a use and apply the sound transit language from various parts of the code to the MFPs. Goes back to what I have continually said that the code does not currently consider staging a use that requires a MUP. I have asked for the amendment language before to no avail.
