Yesterday, Rick Conte stopped a process, by which AWV designers and the reviewers on the subject project were going to meet and review how the design team addressed changes to comply with the review comments which had not been either resolved or shown how these changes were ultimately incorporated. Rick has suggested a procedure which has the City receiving a 5 volume set of plans and specifications and for practical purposes reviewing again since we will not have access to project designers and how they addressed issues.

You mentioned that it was your goal to have these issues resolved and completed by Wednesday of next week. Physically, this new approach will not allow for us to complete our work by Wednesday.
