The SR 99 bored tunnel project, if approved by the legislature, will bypass the Battery Street Tunnel and it will likely be decommissioned. We are considering options for interim maintenance of the BST but probably will not go to ad with a construction contract. We need to wait for the end of the legislative session to confirm this, but that's where we are at right now. The funds for BST would need to be rolled into the bored tunnel project by combining PINs or redefining the BST project summary through the PCR process. We will need to get back to you again around May 1 to confirm all of this.
