We want to recreate the grid at Alaskan/Dearborn/1st Ave and possibly one block south of there and pull all surface Alaskan Way traffic to 1st while creating a new N/S roadway between AW and 1st for ramp traffic south to Royal Brougham Way. I would also ask that the ramps be one color, city streets a different color, and SR 99 a third color. Can you and I get together with John to go over this quickly?

The attached map is what we're currently using on the Web site and in printed materials to illustrate the bored tunnel hybrid alternative to the public. As you can see, the depiction of the south end isn't very effective in conveying the latest design. I spoke with Ali about this last week, and he suggested I talk with you, Alec, since any update would have to include how the south end project will interface with the bored tunnel.

We have a legislative briefing on Thursday, and would like to be able to offer them a more accurate representation of the south end design. I understand that things are changing quickly, but would it be possible to come up with an improved rendering? It could be cartoonish, if it had to be, and we would be sure to include a caveat that the design is still evolving.

I know this is late notice, but our goal is to get something approved by the end of Tuesday, for inclusion in Thursday's presentation. Your help would be greatly appreciated.
