Theresa rocked and rolled at the strategy meeting this morning -- she was throwing around the lingo so well that Dave and Craig mistook her for a tunnel construction expert at one point.

Here are a few things that came out of the meeting. Please add anything I missed, Theresa.

- General agreement on city being co-lead; need to focus March 3 tri-agency conference on scope of bored tunnel EIS (seawall, waterfront surface street being two important issues)
- Also at March 3 tri-agency need to focus on roles and responsibilities during the environmental process. Mattern has put together a proposal, which can support the discussion. Need to do some advance work with Powers on this one.
- Need to add AWV environmental document review to state agency directors' meeting agenda (being planned for 520 in March). Both projects are going to have reports out for review at the same time and agencies (including WSDOT...) are going to have issues with workload.
- Cash flow requirements were handed out -- some direction to project team about how to make 09/11 better, understanding it makes future years a bigger lift. Theresa can probably add more.
- Want to keep ad date for stage two of H2K in September.
- Agreement on PDR approach.
- Legislative responses out for review; more conversation needed on risk question (John -- I'll ask Sally to set up time for us).

There were a few other discussions, but these are the major ones.
