I discussed this with Mike Morrison on Wednesday and we concluded that you would probably be looking at an increase of 50+% of the tunnel costs. This of course is a back of the envelope type of guestimate. Probably an additional \$1 billion above the current most probable \$2.13 billion. Very complex construction, very high risk and challenging geometry.
