If Ron is willing, there are two potential topics that he could present to the group:

- 1. The general volume shifts that might occur due to the tunnel. This would be akin to the line drawing on the white board in Ron's office that he drew for Eugene Wasserman. It shows the volumes in the Tunnel and on the surface waterfront route. This group has never seen the data from the AWV Stakeholders group that showed the various volumes for the 8 alternatives, so that might be something that could be used.
- 2. A discussion of the issues and choices related to the North Tunnel Portal. Various members have heard many rumors about the location of ramps to Denny Way; the potential that those ramps could interfere with crossings of Aurora Avenue between Denny and Mercer Street; potential rerouting of the existing Viaduct route to construct the tunnel; and how it might tie into the grid.
