DeWitt,

There are a number of things on the PDF from ROMA that are different from what we discussed.

1. There is no intention to replace the Lenora Street Bridge. It is a historical structure and should remain.
2. The grassy steps shown at the Pumpkin and Bigman site. My impression was to complete this with as little right of way acquisition as possible. We need to get clarification from Management that WSDOT will acquire this site.
3. The sharp left hand turn from Western to Elliott is not constructible due to slope and the sharp 270° turn is not desirable. I was under the impression this turn movement would be to Blanchard leaving the old Elliott right of way for development or pedestrian/bicycle traffic. Why was this changed.
4. There are too many independent pedestrian crossings for the Elliott Southbound route.
5. The Elliott to Western route should come up Blanchard as we discussed in the meeting.

Will you please set up a meeting with Rick, Alec, You and Me to discuss this.
