A sketch level look by PB at possibly having bored tunnel ramp access to/from Denny has been done as you've

requested. As you can see in Stephanie Kirby's brief recap below, ramps would be in excess of 20% grades with an assumption of designing them with 15mph design speed (I'm sure that was for the vertical curve as you tie into Denny). The ramps with vertical curves designed for about 15 MPH and a slope of 22.5% we could do it vertically from the tunnel portal to Denny Way.

In such a restricted space, I do not believe possible to separate horizontally. (therefore the unbraiding would not happen until north of Denny)
