Pam and Brian:

AWV Contracts would like to move forward with new Task Order Y9715 CK – AWVSRP Moving Forward – SR 99 Early Safety and Mobility Projects – Project Management.

Per discussion with PB and the STATE, TO Y9715 CK will replace CONSULTANT PB's current TO Y9715 AA - *Project Management* - at the end of the current biennium. TO CL will provide continued PM support for both the remaining Moving Forward Projects and the Bored Tunnel alternative into biennium '09-'11. Something this summer, AWV will close out TO Y9715 AA.

As you may not be aware, the STATE is working to extend PB's current Y9715 agreement from December 2009 to December 2010 such that their proposed budget for CK will reflect this time period. Currently, Y9715 ends December 2009.

Funding requested for this TO is between \$6M and \$8M (not negotiated yet).

Before moving this Task Order amendment up the Chain-of-Command, I would like to know:

For the AWV Budget Group – any reason(s) we should not proceed with the request?

For the AWV Project Controls Group – any reason(s) we should not proceed with the request?
