Bill -

Thanks for talking with about the south portal working group for the Alaskan Way Viaduct program. Here are a few more details -- please let me know if you have questions, or if you need other information. We hope that someone from the Bloxom Company will be able to participate.

To help inform the design and environmental process, WSDOT, the King County Dept. of Transportation and the Seattle Dept. of Transportation are establishing three working groups that will concentrate on the following areas: central waterfront, north portal and south portal. We invite you to be a member of the south portal working group. This group will be a sounding board to the three agencies.

As a member of the bored tunnel's south portal working group, you will discuss and weigh-in on the design and mobility, including access into and around the south entrance to SR 99 bored tunnel, urban design features, and

construction plans.

Your role as a member of a working group is to advise the program team and communicate with your community. The working groups will not be asked to make or give a final recommendation or take any votes. We will begin to meet with the groups in May, with the first meeting being either May 6 or 7, from 4 to 6 p.m. Because we need to get input on the portal designs so they can be analyzed in the environmental document, we need to have three meetings with the south portal working group in May and June. Other potential meeting dates during these months are May 20 or 21, and June 3 or 4. We propose taking the summer off to allow the environmental analysis to take place and start again in the fall with monthly meetings for each group as is warranted by the availability of technical information.
