Thank you to all who attended this morning's Working Waterfront Forum. We hope you found it as useful as we did in sharing issues and perspectives.

This e-mail provides two attachments regarding Tunnel Cost Estimates, discussed this morning :

- 1) Bob Donegan's e-mail summarizing the tunnel meeting last night, including his cost summary distributed this morning
- 2) Viaduct Project Team's tunnel cost estimate, presented last night but not available as a handout, until Ron Paananen provided today

Our comparison shows that the component costs are the same, as far as "All costs of deep bore tunnels" and "Program Costs for Tunnel Only."

However, the bottom line totals provide different summaries ("Total Program Costs for SR99" vs. Donegan's "estimation of Deep Bore-Surface Hybrid"), resultingly with different total dollar values.
