All,

In the effort to share available info in real time, a few things need to be pointed out related to the draft hybrid estimates you received:

- The I-5 costs do not align with the updated costs that Susan Everett and the I-5 team provided late on Friday. It appears there were questions on what parts of the scope were in/out between scenarios, and those questions weren't resolved in time. We will quickly work on the revisions to ensure the I-5 costs reflect the best information we currently have, expect the Surface & Transit hybrid I-5 costs to go up a bit and the Bypass scenario I-5 costs to go up quite a bit.
- The Bored Tunnel costs included in the spreadsheet were for the single bore, which has not been endorsed by agency execs. My understanding is that was being vetted at the tri-agency meeting and possibly revised back to the twin-bore number.
