## Comments:

Under Assumption C: please don't indicate hard and fast detour speeds or durations- we will continue to look for ways to get better geometrics as the design progresses. I heard that we could get a minimum 25 but could probably do better. I think the 1 month threshold is ok, but we are also looking for ways to confine the durations even more if possible.

Assumption D: October 2010 is the ROD date, not 2011.

Assumption F: I would include this with Assumption C - same topic area. I would not state that we can close 1st Ave for 18 months, I would state that we think it will take an 18 month closure and that it is a big concern to the city and the Pioneer Square community.

General Comment- please do not use the term "Weave" to describe the transition from stacked to side-by-side. A weave is a traffic term describing two traffic flows (same direction) intersecting and crossing. A more appropriate term would be stacked to side-by-side transition (or vice versa). You could also use just "transition" for short if you want to.
